Booth Details

Each space is approximately 6' X 5'. We will provide one 6' table and 2 chairs per booth space, but you are welcome to use your own display pieces instead. A limited number of electrical outlets will be available and must be requested on your application form.

Location

The show will take place right in the heart of Queen Anne at the Queen Anne Community Center.

Promotion

This show will be promoted throughout Seattle with posters in high traffic locations. Postcards will be made available for you to share at other shows. The show will be listed in the Queen Anne and Magnolia News calendar, ETSYRain, FestivalNet, the Stranger, Craigslist, and emails will be sent to several blogs, email groups, and artist groups throughout Seattle. The QA Trunk Show has its own Facebook page where we will promote the event and each of our vendors, as well. We will also encourage word of mouth and email promotions through the many, many current and former Sweet Pea families.

Who We Are

Sweet Pea Cottage is a non-profit arts preschool located in Queen Anne, Sand Point, and West Seattle. We create a garden of possibilities where children ages 2.5 to 6 learn through a wide variety of experiences. Fees

If you are a Seattle-based artist and do not have a Seattle business license, please add \$5.00 to your registration fee. Please do not send any fees at this time. We will provide payment information if you are selected for the show.
